Under the powers delegation vide reference 1<sup>st</sup> & 2<sup>nd</sup> the inspection committee of the Fire Prevention Wing has inspected the existing Multi-storeyed School Building of SARASWATHI HIGH SCHOOL, 505/A, Yeravalli X Roads, Itikyalla Mandal, Mahbubnagar Dist. 509125 on 28/09/2016 and submitted the following report.

The management has occupied the Multi-storeyed existing school building consisting of Ground + 2 floors with a height of 13.91 Metres for Educational Occupancy (School). The Management has submitted application for the issuance of Fire No Objection Certificate for existing building.

4) Strict compliance with all fire safety provision as per the condition of <u>Fire No Objection Certificate</u> issued vide Part 4 National Building code of India and of Building rules, particularly the following should be ensured at all time.

Fixed and First-aid Fire Fighting equipment, alarm etc shall be tested and maintained regularly as per applicable standards and Fire Drills conducted quarterly for first two years and three after half yearly.

No temporary structure such as tents or with thatched construction should be allowed for educational institutions.

Emergency power generator etc., and associated equipment like feeds, should periodically verified as per NBC, and IS-1646.

Every room with a capacity of 45 students shall be maintained obstruction free minimum two doorways. Every vertical opening between at the floors shall be suitably enclosed or protected, with ventilation System by ducts and Balconies.

The Builder/ Occupier should facilitate periodical inspection by jurisdiction Station Fire Officer and District Fire Officer, Fire Prevention Wing, GHMC, Hyderabad.

- 5) In view of the above Fire No Objection Certificate for the Existing Building from the fire safety points of view is issued subject to the following conditions.
  - 1) The NOC issued is confirmed to the Fire Safety measures installed in the building and doesnot confer any Legal right for claiming Ownership of property or Conversion of land use/ Occupancy or Building Regularization. The Owner/ Occupier shall comply the Building Rules/ Govt. Orders as applicable.
  - 2) Evacuation plan showing exist routes and recommended action plan be displayed at conspicuous locations and shall be exhibited at all times all escape/exit routes shall not be locked or encroached.
  - 3) Fresh NOC would be required for any change in occupancy or addition/alterations in the building structure as per NBC and building bye laws.
  - 4) The management has to maintain Fire Safety measures at all times in good working Condition as seen during the inspection.
  - 5) Any loss of life or property due to Non-functioning of Fire Safety Measures and other installations shall be the responsibility of the management/owner.
  - 6) All the occupants should know the correct method of operation of the Fire Fighting System installed.

- 7) All the occupants/ security personnel shall be trained to operate the Fire Safety Equipment during the Emergency.
- 8) Additional/ Alteration, if any, in the building may be verified by building authority.
- 9) The Fire Drills shall be conducted once in every six months for initial two years, thereafter once in every 6 months.
- 10) Fire No Objection Certificate issued is valid for one year from the date of issue. It is the responsibility of the Builder/ Occupier to apply for renewal one month before expiry.
